It contains responses from both countries to questions on foreign and security policy, global affairs.

Briefing Note: Government Responses to Citizen Claims of Rendition and Torture On 26 September 2002 Canadian, Maher Arar, was detained in New York by US officials, acting upon information supplied by the Royal Canadian Mounted Police. Despite carrying a Canadian passport, he was deported to Syria in accordance with a U.S. policy, "extraordinary rendition". Arar was held in solitary confinement in a Syrian prison until his release in October 2003. A Canadian Commission of Inquiry confirmed Arar's claims of torture and that there was never any evidence linking Arar to extremist or criminal groups. The Canadian parliament issued a unanimous apology to Arar, and Prime Minister Stephen Harper made a direct formal protest to President George Bush by telephone on 6 October 2006. The case exemplifies differences in approach to the rights of citizens claiming to be victims of illegal torture and rendition taken by different governments.
