Plan for Councils Adapting to Climate Change - Australia

This report deepens the understanding of the most common cross-cutting barriers to climate change adaptation (identified in the earlier reports of the project) in local government. It informs the feasibility of future strategies to better manage the barriers. The report provides some recommendations to improve the adaptive capacity of local government.

The study reviews the literature/recent work applied to transport sector and identifies effects of climate change and weather conditions on this sector. Despite the insights raised in this study, it emphasises that the net impact of climate change on generalised costs of the various transport modes are unsure and vague.

Climate Change Implications on Food Production - Ethiopia

The paper examines the impact of key climatic variables on food production in the Nile Basin of Ethiopia, using household-specific survey data. It provides the implications of adaptation strategies on farm productivity. The paper finds that climate change and climate change adaptations have significant impacts on farm productivity.
