1. Victorian Local Government – Case Studies Report

The report presents a detailed account of the level of Victorian local government activity in greenhouse mitigation and climate change adaptation. It provides an overview of the barriers to local government involvement across the state and proposes a number of recommendations to overcome them. The report contains 11 case studies to share knowledge and expertise within the sector.

2. California – Actions to Reduce GHG Emissions

The document describes the Air Resources Board (ARB) staff's analysis and recommendations for discrete early action measures to reduce global warming emissions. These measures will become part of the State's comprehensive, multi-year program with the overall goal of restoring emissions to 1990 levels by the year 2020.

3. Analysis of Vattenfall's 'Fair Climate Regime'

The paper scrutinizes the Vattenfall's proposal (the first major corporation to present a detailed and quantitative framework for a global climate regime) against the criteria of adequacy and equity. It examines the Vattenfall's proposal in several different ways. Underlying all of them, however, is the question: "How effectively will the proposed framework protect what we call developmental equity?"

4. Sectoral Agreements in a Post-2012 Climate Framework

The paper examines the broader policy and structural questions relating to the development of sectoral approaches to climate change at the international level. Key issues include: different international sectoral approaches; the relative advantages of sectoral agreements; factors that make sectors more or less suitable for a sectoral agreement; and variables that must be addressed in developing these agreements.

5. Enhancing Adaptation Capacity to Climate Change - Botswana

The paper focuses on how adaptation to climate variability can contribute towards building self-sustaining community adaptation capacity to climate change stresses in the Limpopo River Basin part of Botswana. It assesses the effectiveness of past strategies used by rural communities to reduce the negative impacts of climate variability.
