### 1. Adapting Agriculture to Future Climate Change

The paper outlines a large array of possible adaptation options for cropping and livestock systems, forestry, and fisheries. It uses the literature on crop yields as an example to assess the benefits of adaptation. The paper suggests some general pathways that can help move from technical assessment of adaptation options to more practical action.

### 2. Health, Environmental Challenges and Urban Development

The paper examines urban health in low-and middle-income countries, in relation to two sets of environmental issues: persistent local environmental health burdens (water, sanitation and housing deficiencies); emerging global environmental burdens (climate change). It situates these issues within a policy-relevant framework that can help to elucidate the sorts of strategies best able to address them.

### **3. Bali Climate Change Conference 2007 - On the Road Again!**

The paper assesses the progress made in the Bali Climate Change Conference 2007 on Adaptation Fund and finalizing an agreement for post-2012. It considers countries' negotiating positions and concludes that a successful outcome in the future will require a compact between North and South that involves assistance for developing countries to take action.

### **4. Climate Change Adaptation Research in China**

This paper provides an overview of climate impacts, vulnerability, adaptation assessment and options undertaken in China to date. It notes that adaptation research in China is mostly theoretical and is at a preliminary stage. The paper stresses the need for international cooperation to carry out climate change adaptation research in China.

### **5. Enhancing Community Solidarity through CBDM - Bangladesh**

The study highlights how community-based disaster management (CBDM) contributed to enhance community solidarity and capacity (10 flood-prone communities in four districts of Lalmonirhat, Kurigram, Sirajganj and Tangail) to cope with the annual flood in Bangladesh. The key outcomes show that CBDM has increased awareness for reducing risk of natural hazards.
