Briefing note: Navy Fires on Illegal Fishing Boat

Illegal fishing boat intercepted after shots fired, ABC New Online, February 19, 2006.

Defence Minister Brendan Nelson has confirmed <u>another large illegal fishing boat has been</u> <u>intercepted in Australia's northern waters</u>, 25 nautical miles within Australia's economic exclusive zone, north of Darwin. This follows the detection of a Chinese boat a week ago that is believed to have been acting as a large freezer for illegal fishing operations. Dr Nelson has told Channel Nine that force had to be used with the Indonesian boat.
