DCA CIRCULAR 640-45-5*

ORGANIZATION

Defense Communications Agency, Pacific Area

- Purpose. This Circular assigns the mission and responsibility of the Defense Communications Agency, Pacific Area (DCA-PAC), including functions related to the National Communications System (NCS), and delegates required authority to its Commander.
- Applicability. This Circular applies to Headquarters, DCA; DCA field activities; and Office of the Manager, NCS; and is furnished for information to other activities.
- Reference. DoD Directive 5105.19, Defense Communications Agency (DCA),
 August 1978, as amended.

4. Command.

- a. The Defense Communications Agency, Pacific Area, is a field activity of the DCA and a subordinate element of the Defense Communications System Organization (DCSO), under the command of the Director, DCA. It is commanded by the Commander, DCA-PAC, who reports to the Director, DCSO. In the event of a major emergency in the DCA-PAC area of responsibility, which necessitates the use of all available forces, the Commander-in-Chief, Pacific (CINCPAC) will assume temporary operational control of DCA-PAC and its assigned geographical area.
- b. The Commander, DCA-PAC, exercises command authority over the DCA regions and field offices and operational direction over the Regional Communications Operations Centers (RCCC's) within the assigned geographical area.
- 5. Mission. The mission of DCA-PAC is to exercise operational direction and management control of the Defense Communications System (DCS) within the assigned geographical area in order to support USCINCPAC in the execution of DCA-PAC assigned mission and to meet DoD telecommunications requirements. DCA-PAC assumes, on order, and executes additional missions related to the non-DCS functions of the DCA. Operational guidance and instructions relative to assigned NCS functions are provided by either the Director, DCSO, or the Commander, National Communications System/Defense Communications Agency Operations Center (NCS/DCACC), as appropriate.
