Korean-American activists gathered outside the White House during a state dinner between Pres. Lee and Obama to protest the FTA and the construction of a naval base on Jeju, but were shut down by the Secret Service for being a security threat.

Rate regulation of energy utilities as typically practiced is in conflict with providing utility programs to improve consumers' energy use efficiency, since sales decrease as energy use falls. Six Japanese doctors returned from a trip to North Korea where they interviewed and treated victims of the 1945 atomic bombing of Hiroshima who now live in the DPRK. "We will urge the Japanese government to support the North Korean survivors who are aging and have little time left to live," said Shizuteru Usui. Until now, the DPRK insisted that it provides the hibakusha with the best care possible and Japanese specialists have nothing to offer it.
