### 1. ROK-DPRK Summit

The DPRK agreed to an ROK proposal to hold preliminary talks among working level officials at Panmunjom on April 22 to discuss preparations for the June summit meeting.

### 2. ROK-DPRK Economic Cooperation

ROK Foreign Minister Lee Jung-binn attributed the DPRK's willingness to take part in June's summit meeting to its need for economic aid to rebuild its economy. Samsung and LG Electronics announced that they would soon begin selling televisions manufactured in the DPRK. The American Chamber of Commerce in the ROK announced plans to form a joint venture group to help ROK and foreign companies invest in the DPRK.

The US decided to sell long-range radar to Taiwan, but not Aegis destroyers. US critics claimed that the Clinton administration was leaving Taiwan unable to defend itself, while the PRC said that any arms sales to Taiwan were provocative.

Japanese Foreign Minister Yohei Kono said that Japan would push for faster implementation of existing arms control agreements and moving forward on new treaties during the upcoming review of the Nuclear Non-Proliferation Treaty. The Japanese Study Group of Peaceful Uses of Nuclear Energy and Non-Proliferation Policy stated that the maintenance of an efficient global nuclear non-proliferation regime as well as ensuring safety are major premises for the smooth, peaceful use of nuclear energy.
