SECTION I. GENERAL

- 1. PURPOSE. This regulation governs all peacetime deployments to Republic of Korea (ROK) air bases and use of ROK facilities at ROK air bases by US Forces units not assigned in the ROK. It prescribes the requirements for coordination of deployments to ROK air bases and the information and support required of the deploying unit.
- 2. SCOPE. This regulation applies to all US Forces deploying aircraft and/or personnel to ROK air bases.
- 3. REFERENCES. a. PACAFR 55-21 (Tropical Cyclone Protection and Weather Evacuation of Aircraft (SAFE HAVEN).
- b. AFR 76-38 (Military Airlift Command Requirement Submissions, Space Assignments and Allocations and Procedures).
- 4. EXPLANATION OF TERMS. a. ROK air bases. All military air bases and airfields in the ROK.
 - b. ROKA air bases and airfields. ROK Army is the controlling authority.
 - ROKAF air bases. ROK Air Force is the controlling authroity.
 - d. ROKN air bases. ROK Navy is the controlling authority.
 - e. USA air bases and airfields. Commander, EUSA is the controlling authority.
 - f. USAF air bases. United States Air Forces Korea is the controlling authority.
- g. USAF-ROKAF bases. ROKAF air bases with USAFK units assigned (Suwon, Taegu, and Kwang-Ju).

- h. Trusted agent. The individual designated to coordinate support for inspection teams or exercise controllers prior to and during operational readiness inspections or exercises.
- 5. RESPONSIBILITIES. The USAFK Deputy Chief of Staff, Operations (DO) is the single point of contact (FOC) for coordinating peacetime approval and disapproval of USAF deployments to all ROK air bases. COMNAVFORKOREA is the single POC for coordinating peacetime approval and disapproval of USN/USMC deployments to all ROK air bases. CDRUSAEIGHT (CJ-EA) is the single POC for coordinating peacetime approval and disapproval of USA deployments to all ROK air bases. COMNAVFORKOREA and CDRUSAEIGHT (CJ-EA) will coordinate use of USAF, USAF-ROKAF and ROKAF controlled air bases through USAFK/DO. USAFK/DO and CDRUSAEIGHT (CJ-EA) will coordinate use of ROKN controlled air bases through COMNAVFORKOREA. USAFK/DO and COMNAVFORKOREA will coordinate use of USA controlled airfields through CDRUSAEIGHT (CJ-EA). All POCs will coordinate use of ROKA controlled airfields through CSROKA AVN, Seoul Korea.

SECTION II. COORDINATION REQUIREMENTS

- 6. MISSIONS REQUIRING COORDINATION. Units flying aircraft into air bases in the ROK intending to remain overnight (RON), operate from, or use air base facilities for other than a single approach, normal landing, routine transient service, takeoff and departure, must have prior coordination and approval through the applicable POC. Exceptions to this policy are:
 - a. MAC channel traffic.
 - b. MAC air evacuation flights.
- c. MAC special assignment airlift missions (SAAM) which operate into USAF and USAF-ROKAF air bases using USAF facilities and MAC traffic personnel and other ROK air bases if the SAAM user has received approval from the controlling headquarters for use of the facilities.
- d. Four or less fighter type aircraft on cross-country missions to Osan or Kunsan requiring only standard transient services.
- e. Peacetime aerial reconnaissance program (PARPRO) aircraft deploying to Osan or Kunsan air bases.
- f. Aircraft deployed to SAFE HAVEN bases in support of typhoon evacuation plans directed by PACAFR 55-21.
- 7. PERSONNEL DEPLOYMENTS. Detachment size or larger deployments of US personnel to or through USAF/USAF-ROKAF air bases and all deployments of US personnel to other air bases in the ROK require prior coordination and approval through the applicable POC.
- 8. FLIGHTS TO ROK AIR BASES. All units flying aircraft to ROK air bases will provide flight advisories (addressed IAW appendix A, figure 1, 2 or 3 as applicable) no less than 96 hours prior to the planned arrival times. Exceptions to this policy are:
 - a. MAC channel traffic.
 - b. MAC air evacuation flights.
 - c. Rotational aircraft assigned to forward operating locations and detachments in Korea.
- d. Aircraft deployed to SAFE HAVEN bases in support of typhoon evacuation plans directed by PACAFR 55-21.
- 9. EMERGENCY DIVERT BASES. All units requiring designated ROK emergency divert air bases will send an advisory message addressed IAW appendix A, figure 1, for USAF units; figure 2 for US Navy and Marine units; or figure 3 for US Army units. Include the number and type of aircraft, dates and times of vulnerability, and type of ordnance being carried if applicable. This message must arrive no less than 96 hours prior to the first area flight.

SECTION III. RESPONSIBILITIES OF DEPLOYING UNITS

10. UNIT DEPLOYMENT REQUESTS. All units deploying aricraft or personnel to air bases in the ROK will comply with the requirements in the following paragraphs as they apply to the particular unit's deployment. Failure to meet the deadlines established for requests may result in limited availability of requested support and services or the disapproval of the deployment due to insufficient resources or time to effect required coordination. Requests for

deployments to air bases in the ROK should be addressed as in appendix A, figure 1 for USAF units; figure 2 for US Navy and Marine units; and figure 3 for US Army units. A unit POC knowledgeable about the deployment and available before, during, and after the event will be provided in all requests and advisory messages. Any changes to deployment and redeployment dates, number and type of aircraft or personnel, or purpose of the deployment must be coordinated prior to execution.

- 11. COMPLIANCE WITH USAF FOREIGN CLEARANCE GUIDE AND FLIGHT INFORMATION PROGRAM (FLIP) PUBLICATIONS. The deploying unit is responsible for complying with the requirements of the Foreign Clearance Guide with respect to the requirements for aircraft and personnel entering the ROK. They will also comply with FLIP publications and notices to airmen (NOTAMS) with respect to operational restrictions at the prospective deployment base unless specific permission to deviate has been granted by the controlling authority. The operator of aircraft deploying personnel is responsible for complying with the above requirements except as exempted by AFR 76-38, paragraph 27.
- 12. CONTENT AND TIMING OF REQUESTS. Units requesting to deploy aircraft to and operate out of ROK air bases will forward a request at least 60 days prior to the desired deployment date. This request will contain, as a minimum, the following information:
 - a. Unit deploying.
 - b. Purpose for deployment.
 - c. Requested deployment or redeployment dates.
 - d. Requested deployment base and alternates if preferred base is not available.
 - e. Number and type of aircraft.
 - Range or airspace requirements.
 - g. Special needs or considerations associated with the unit or aircraft.

Deployment requests received between 60 days and 30 days prior to the requested deployment date may not allow sufficient time to coordinate all requested support and services (e.g., range time, assistance in preparing fragmentary orders (FRAGs), etc.). Requests received later than 30 days prior to the requested deployment date leave no time to explore alternatives and may be disapproved with little prior notice to the requestor.

- 13. USAFK LOCISTICS SUPPORT. Units requiring USAFK logistics support will forward requirements to Det 1. USAFK Logistics (LG), Seoul, Korea no less than 45 days prior to the deployment date or as specified in the unit's Host Tenant Support Agreement with USAFK when applicable. The request should include the following information:
- a. Billeting requirements (number of officers, females, senior enlisted and enlisted personnel).
 - b. Ground support equipment requirements.
 - c. Transportation requirements.
 - d. Tuel requirements.
 - e. Munitions support requirements.
- 14. USAFK FRAG SUPPORT. Agencies or units requesting USAFK support in writing air tasking orders for exercises or operational readiness inspections will provide USAFK, Osan AB, Korea, Combat Plans (DOCK) and Det 1. USAFK, Seoul. Korea, Asst Deputy Chief of Staff, Operations (ADO) (trusted agent) the following information, a minimum or 45 days prior to the deployment date.
 - a. Unit(s) to be tasked.
 - (1) Type(s) and number(s) of aircraft to be deployed.

- (2) Location(s) of deployed aircraft and type and number of aircraft at each location.
- b. Sortie requirements for sustained operations.
 - (1) Sortie rates and total number of sorties needed.
 - (2) Minimum turn-around time.
 - (3) Number of day/night sorties.
 - (4) Duration of day/night sorties.
 - (5) Desired sortie flow schedule.
 - (6) Number of air-to-air refueling sorties.
 - (7) Maximum number of sorties for first launch.
 - (8) Estimated number and types of missions desired.
 - (9) Ordnance load, standard conventional load (SCL) or plain language.
 - (10) Training range and airspace (ZONE) requirements.
 - (11) Special range requirements (e.g., live drops).
 - (12) Limiting factors affecting a unit's deployment.
- c. Sortie requirements for special or surge operations. Provide information requested in b above if applicable.
 - d. Call signs to be used.
 - e. Any special operating instructions (SPINS) to be included in the FRAG.
 - f. A list of trusted agents for the exercise if applicable.
- g. The requesting organization will identify a point of contact and primary FRAG writer and coordinator for the exercise. Normally this individual will be required at USAFK (DOCX) Osan AB, Korea a minimum of 2 weeks before the exercise is conducted. This will allow time to accomplish final coordination and prepare the final FRAG with DOCX assistance. This individual will remain on station for the duration of the exercise and act as the on-scene daily FRAG writer and coordinator.
