1. Community Activities:

a. A meeting was held with the Naehaeng Dong (southern district in TDC) Chief, Mr. Kim, and CMO on Friday, 8 May 1987. Mr. Kim's office provided an excellent briefing and information to highlight his area's importance in Dongduchon. During his proposal for closer ties with the DCI and 2ID, he indicated three important items: 1.) The '88 Olympic Torch route will enter TDC and turn around at Gate #1 Camp Casey (similar to '86 Asian Games Torch route); 2.) He offered thousand of flowers and free labor support near the end of June 1987 for Camp Casey's use; and 3.) He also offered, on behalf of the city, some land (400-500m²) for use to develop a 2ID symbol to "welcome" '88 Olympic's visitors to the city where the "Warriors" are located. This land is located (going South to North) on the right side of the MSR3 about 300 meters south of the first red light (southern tip of city).

b. On 13 May 1987 at 1100 hours CMO held a meeting between Ms. Lee Choon Hee (Chairwoman of Myung Woo Circle, street girl's association) and Ms. Kim Keum Soon (manager for business girls at 429 1/1, Bosan Dong, TDC). At the meeting, we discussed the seriousness of the VD problem at Ms. Kim's establishment, ways of alleviating this problem, and possible actions if the VD problem is not cleared up immediately.

c. The CMO Health Team coordinated for the Community Health Nurse, CPT Eddinger, to present a VD class to the Myung Woo street girl's association yesterday, 14 May. The VD class centered on types of diseases and prevention. Future VD brief are planned for the Restaurant Association (non-KTA) clubs by the CMO Health Team.

Dear Mayor Kim:

The residence located at Sang Yeon 4 Dong 567 9/5 and owned by Ms. Oh Young Rae (See Encl 1 for a strip map), has been recommended to me to be placed off-limits to all 2ID soldiers because of the number of reported cases of venereal disease identified as originating in this establishment. This condition, if not corrected, will be referred to the Armed Forces Disciplinary Control Board (AFDCB) within 30 days from the date of this letter.

It has been determined by the Civil Military Operations (CMO) Division that between 13 October and 23 October 1987, a total of 4 cases of venereal disease among USA soldiers originated in this establishment. The women involved are listed below. (See Encl 2 for a detailed list of venereal cases occurring since 16 March 1987 in this establishment).

Park, B. R. - 3 times (Health Card # H 678)

Kim, M. H. - 1 time (Health Card # C 2314)

This situation clearly threatens the welfare of 2ID soldiers and can not be allowed to continue. I ask your cooperation in resolving this problem immediately. If we are unable to resolve the situation, I will have no alternative but to recommend to the Armed Forces Disciplinary Control Board (AFDCB) to proceed with an off-limits action. The occurrence of only one more venereal disease case during the warning period (5 Nov - 4 Dec 87) will prompt me to recommend off-limits action to the AFDCB. In this case, Ms. Oh Young Rae and/or city authorities will be invited to present to me personally any information which may affect my decision. If this meeting becomes necessary, you will be notified by letter of the date, time, and location.

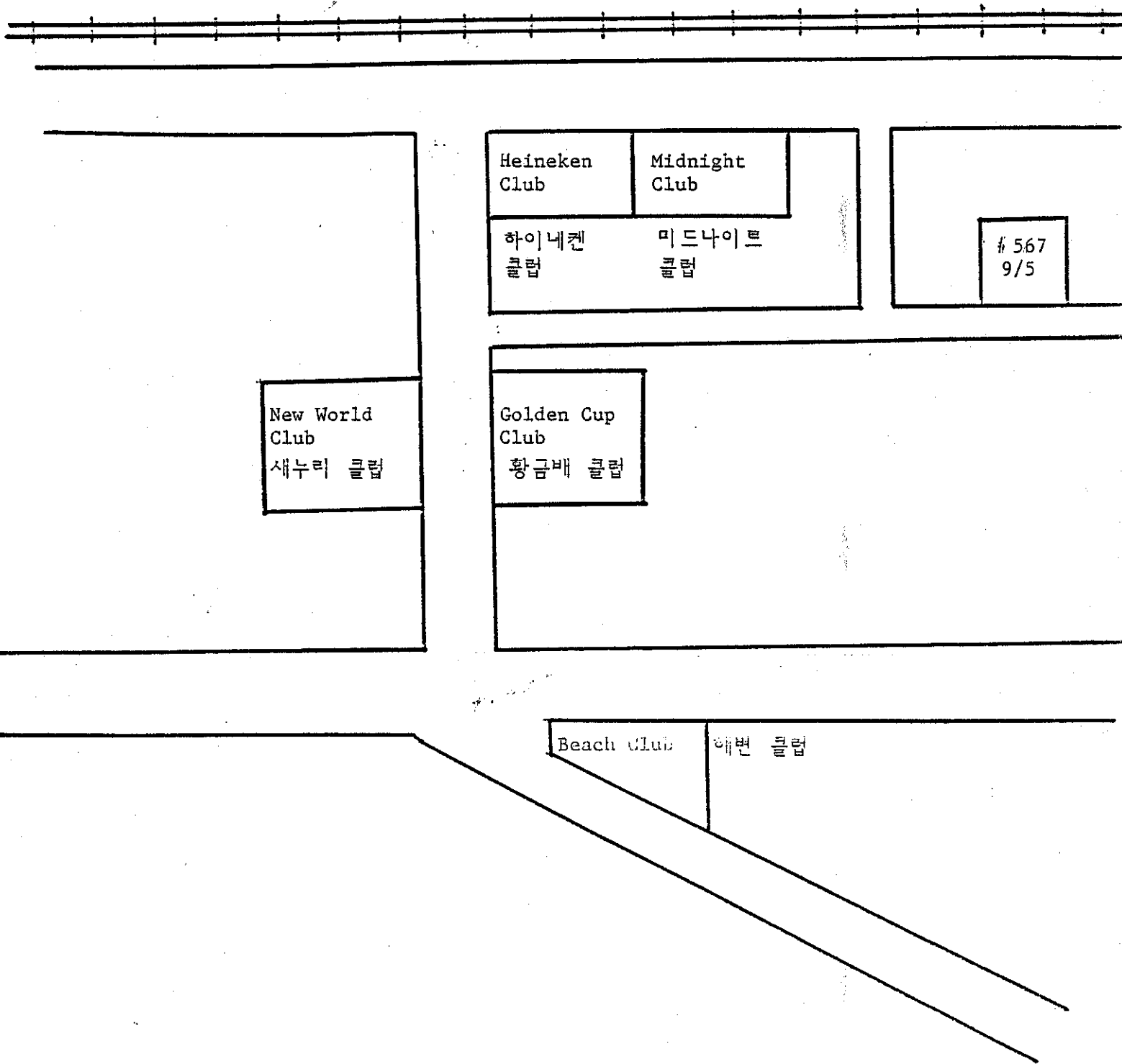

안녕하십니까:

이 시신은 동두천시 생연동 543 에 위치한 량대부 라고 불럭우는 클럽이 다음과 같은 이유로 인하여 미 제2사단의 모든 군인들로 하여금 출입금지 실시되도록 본인에게 건의된 것에 대한 공식경고입니다. 이는 다음과 같은 이유들로서:

- (1) 이 클럽에서 발생된 것으로 보고된 성병의 높은 발생률.
- (2) 에스코르 되지 않은 민간인들이 귀하의 시설물에 출입하는 것이 금지된 관광협회의 조약 및 법률에의 반복적인 위반사항.
- (3) 안전 수용도 이상 외 입장객 허용.
- (4) 당 클럽 소유주와 경영자의 위문제의 해결에 대한 민사과 직원에 대한 오랜 동안의 비협조성.

3월 3째 주에 민사 과장 대위 캐롤, 동두천 관광협회 지부장 홍 손 암씨와 귀하 사이에 여러차례의 회합이 있었습니다. 그 회합에서는 당 클럽 매니저가 에스코르 되지 않은 한국 여성들을 파악하는데 있어서의 민사과 직원에 대한 비협조가 거론되었습니다. 민사과 직원은 미래의 어떠한 문제라도 해결 하기 위해서는 당 클럽의 적극적인 협조가 절대 필요합니다.

1987년 2월 22일에서 동년 3월 22일 사이에 콘돔을 사용치 않은 미군들이 관련된 5건의 성병건수가 귀하의 업소에서 이루어 졌음이 본인의 민사과에 의하여 보고되었습니다. 총 5건의 성병중 귀하의 업소에서 3명의 여성이 식별되었습니다. 이 숫자는 2사단 규정 360-2에 의하여 규정된 귀하의 시설의 보기에 허용된 수치를 넘었습니다. 식별될수 없는 3건 또는 그 이상의 성병발생은 귀하의 업소에 대한 출입금지 조치를 초래케 할수도 있습니다. 관련된 여성들은 다음과 같습니다.

귀하가 이 문제를 해결함에 있어서 본인의 민사군사운용과와 협조하시기를 주저하신다면 본인은 출입금지 조치의 고력을 진행하는 외에 다른 방도가 없을 것입니다. 이 경우에 있어서, 본인 이 본인이 결정을 하기 전에 앞서 귀하가 본인으로 하여금 고력하기를 바라는 어떠한 정보도 제시키 위하여 본인과 만날수 있도록 초대될 것입니다. 이 만남이 필요하게 된다면 날짜와 시간에 관하여 서신으로 귀하에게 통보될 것입니다.

This letter is an official warning that the (midnight Club has been recommended to me to be placed off limits to all U.S. service members in accordance with the provisions of USFK/EUSA Regulation 190-20 because of the number of cases of venereal disease identified as having originated in your club.

It has been determined by the Civil Military Operations Division that between 1 Feb - 19 Feb 1987 5 cases of venereal disease (3^{with} no condom, 2 condom) among U.S. service members were associated with your establishment. The women involved were:

Miss Kim Moon Hei (C-2197) 3 Times
Miss Jo Kyung Sook (C-1252)
Miss Lee Young Mi

This is in excess of the number of cases determined to be acceptable for clubs of your size, and clearly threatens the welfare of U.S. soldiers. This cannot be allowed to continue. I ask your cooperation in resolving this problem not later than 21 March 1987. The cooperation for which I ask is simply to ensure that employees use condoms in all sexual contacts with U.S. service members.

If you desire further information, please contact Captain Carroll, Chief of Civil Military Operations, located at gate #1, Camp Casey. Any information bearing on this problem which you desire to present to me may be channelled through Captain Carroll.

If you decline to cooperate in resolving this problem, I will have no alternative but to proceed with the consideration of an off limits action. In this event, you will be invited to meet with me to present any information which may bear on my decision. You will be notified by letter of the date and time should this meeting become necessary.


