    - THRUST: who's who in WMD Development

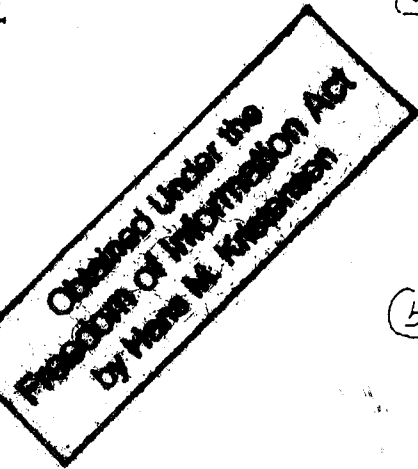
