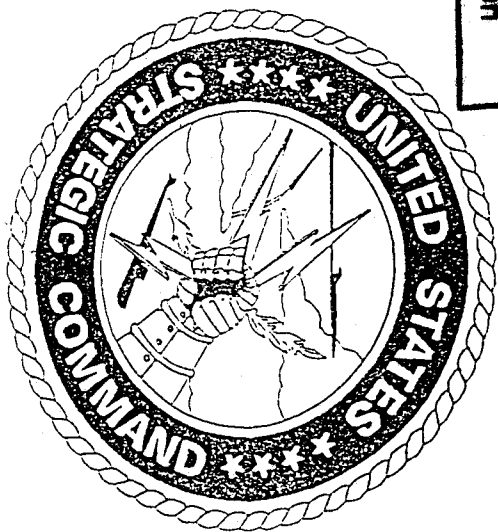

- CHAIRMAN WAS IN KOREA

GUESTS: MR KAY, & DR FETTER, SPEC ASST TO CARTER

OBJECTIVES:

- RECIEVE DR KAY AND DR FETTER BRIEF ON PROLIFERATION
- INITIAL WRITING ASSIGNMENTS

SIGNIFICANT OUTCOMES:

- DISCUSSED HOW NUCS PLAYED IN DETERRENT EQUATION, RELATIONSHIP BETWEEN DETERRENCE/WARFIGHTING & NUC/CHEM/BIO WPNS THREAT
- MAJOR ISSUE: SHOULD CHEM WPNS CONTINUE TO FALL IN THE CATEGORY OF WMD
- GROUP WAS NOT TO CONSIDER ADV CONV WPNS

DR WALLERSTEIN CHAIRED MTG

OBJECTIVES:

- DISCUSS FOUR THEMES:
  - WHAT ARE WMDs?
  - WHAT IS POTENTIAL THREAT TO U.S. INTERESTS?
  - WHERE ARE WE MOST CONCERNED?
  - WHY DO NATIONS ACQUIRE?

CONTRIBUTORS:

- DR WALLERSTEIN: SHOULD WMDs INCLUDE ADVANCED CONVENTIONAL WEAPONS?
  - EXTENSIVE DEBATE--MAJORITY FAVORED EXCLUDING-- NO DEFINITION--HARD TO COMPARE WMDs TO TECHNOLOGY--INCLUSION COULD BLOCK DEVELOPMENT

CONTRIBUTORS (CONT):

- GENERAL GROUP CONSENSUS: WMDs ARE NUCLEAR, CHEMICAL, BIOLOGICAL AND THEIR DELIVERY SYSTEMS-- HOWEVER, FINAL REPORT SHOULD INDICATE ADV CONV WEAPON TECHNOLOGY MAY EXPAND WMD DEFINITION AT LATER DATE
- o POTENTIAL THREATS TO U.S. INTERESTS--HULLCHER SUMMARIZED HIS PAPER
  - INTEL STRESSED, ASSESSMENT DIFFICULT, MAJOR THEME UNCERTAINTY, RESOURCES CONSTRAINED, STRAT FORCES REMAIN BEST HEDGE
- o GROUP OUTLINED THREATS TO U.S.
- o MS WOOLF: U.S. WOULD BE FORCED TO REASSESS OUR VITAL INTERESTS IN EACH REGION AS WMDs SPREAD
- o MR ROWLAND: ANALYSIS OF SEVERAL CASE STUDIES ON COUNTRIES WITH WMD TO PROVIDE MOTIVATIONS

**SIGNIFICANT OUTCOMES:**

- GROUP AGREED ON DEFINITION OF WMDS
- ACCEPTED DIA LIST OF MOTIVATIONS
- AGREED THAT THREAT TO U.S. WAS BASICALLY SOUND
